#### Background

In July of 2009, three families of people served in the Minnesota Extended Treatment Options (METO) program filed a lawsuit against DHS and the State of Minnesota. This lawsuit was expanded to include all people served at METO between July 1, 1997 and May 1, 2011. The lawsuit alleged that the program used restraint and seclusion in a way that broke the law and violated the rights of the individuals. Rather than going to trial, the U.S. District Court for the District of Minnesota adopted a Settlement Agreement on Dec. 5, 2011. This allowed DHS and the plaintiffs to resolve the claims in a mutually agreeable manner.

As part of the Jensen Settlement Agreement (JSA), the Department of Human Services agreed to provide therapeutic follow up to all Jensen Class Members and clients discharged from METO/MSHS-Cambridge since May 1, 2011. The JSA Comprehensive Plan of Action Evaluation Criteria 98 states that "DHS will maintain therapeutic follow-up of Class Members, and clients discharged from METO/MSHS-Cambridge since May 1, 2011, by professional staff to provide a safety network, as needed, to help prevent re-institutionalization and other transfers to more restrictive settings, and to maintain the most integrated setting for those individuals."

Population health has been defined as "the health outcomes of a group of individuals, including the distribution of such outcomes within the group." For this project, the "group of individuals" will include those persons receiving therapeutic follow-up identified above. Medical care is only one of many factors that affect those outcomes. Behavioral risk, including psychiatric diagnosis is relevant as well. Population health strategies have been embraced by many elements of the health care system in the United States, but have been slower to be utilized by services for people with intellectual disabilities.

People with intellectual disabilities (ID) may have physical and mental health (MH) diagnoses. The rate of mental illness is higher among people with ID than the general population. Additionally, behavioral health concerns are often present as well. The rate of problem behaviors is high, and often presents a challenge to community inclusion.

#### Project Description

The Jensen / Olmstead Quality Assurance and Compliance Office will work with the intern to in the development of a population health management strategy, for members of the therapeutic follow-up group. To support wellness and recovery, the JOQACO has developed a checklist with items comprising the most important components of effective supports for people with dual diagnosis (ID and MH). If

A second area of emphasis is to develop strategies for identifying risk factors, which predict behavioral crises or destabilization of current housing

#### Intern Responsibilities

The intern will utilize multiple sources of existing data to gather a precise understanding of the different risks, including behavioral health concerns encountered by Jensen Class Members. Additionally, information will be gathered using the checklist noted above.

The intern will utilize this information, with extensive mentorship and support from the Jensen / Olmstead Quality Assurance and Compliance Office, to design a population health management strategy to support members of the therapeutic follow-up group, potentially using a public health model of supports (primary, secondary, and tertiary levels of intervention).
