Description	<p>Environmental Defense Fund's Global Climate Program seeks an intern in our Washington, D.C. office to assist with our international aviation work. We are currently working to implement the world's first limit on the net emissions of a global industry sector, namely the Carbon Offsetting and Reduction System for International Aviation (CORSIA), which was adopted in October 2016 by the 191-nation Assembly of the UN's International Civil Aviation Organization (ICAO). CORSIA caps the net emissions of international flights between participating countries at 2020 levels, and allows airlines to offset emissions above 2020 levels by utilizing reductions in other sectors – provided those reductions meet CORSIA's emerging standards for emissions unit quality. Ensuring robust and durable implementation of CORSIA, and strengthening its ambition in the future, is our goal.</p>

Overall Function:
Through research and analysis, the intern will support the development of strategies for advancing the implementation of, and broadening participation in, CORSIA.

Responsibilities may include, but are not limited to, the following:

- Developing case studies on the benefits for particular countries of CORSIA participation
- Researching aspects of the aviation industry related to its future compliance with CORSIA
- Developing materials to educate policy makers and the industry on the benefits of linking CORSIA to high-quality emissions reductions, including those achieved at jurisdictional levels
- Assisting with the development and application of models to assess the costs of meeting CORSIA targets
