

### INTERNATIONAL STUDENT CERTIFICATION OF FINANCES 2024-25

The US government requires that colleges and universities determine that a student has assured financial support before issuing the student the Form I-20 (Certificate of Eligibility). F-1 student visa applicants need the I-20 to make the visa appointment at US consulates. Additionally, applicants will bring the I-20 accompanied by financial resource documents to the visa appointment, which will be scrutinized by the consular visa officers. If you already have a valid F-1 visa from studying in the US, Macalester is still required to see the financial support.

- Upload your completed form and supporting bank statements through your Macalester Applicant Portal. Information about acceptable financial documentation is listed on page 2.
- International Student Programs (ISP) will begin reviewing and issuing initial I-20s in May.

This is similar to what you will show when you apply for your visa at a US Consulate or Embassy.

- Tax returns, pay stubs or income declarations, investment statements (including any real estate valuations), will NOT be sufficient to issue an I-20.
- Bank statements need to be as recent as possible. Statements from 2022 will not be sufficient to issue I-20s. Bank statements from 2023 will need to be uploaded through your applicant portal when available.
- Any financial statements or documents should be listed in U.S. dollar equivalents if local currency is shown (e.g., convert 10,000 Euros to US \$11,997, or 100,000 Chinese Yuan to \$15,335, on date of submission).
