## **<u>Land Acknowledgement</u>** ~ *Ryan Connor* ~ 2 minutes

We would like to acknowledge that Macalester College and the College Archives are located on the traditional, ancestral and contemporary lands of the Wahpékhute band of Dakhóta Oyáte, the Dakota nation. We make this acknowledgement to respect and affirm the sovereignty of the Dakota people, ancestors and descendants, and to respect the land itself. We recognize that this acknowledgment is but a first step in recognizing and dismantling aggressive and persistent policies of settler colonialism that continue to oppress to this day. These are the contexts in which the archives functions to this day. The work of acknowledgement must be paired with active practices like the amplification of Indigenous voices and land repatriation in order to be substantive and meaningful. - SOC Code Draft
  - Liv: After last week's meeting we went through and changed the language in the Charted Orgs Rules section to change deactivated/archived to just be deactivated. One thing we'd like outside opinions on would be under Section 4, Items for Consideration of Prospective Organizations, we had some confliction on Failure to Sign with Institutional Values. Does anyone have any opinions on this? Ok, then does anyone want to take a motion?
  - Joel: I was going to ask about an unresolved comment I left on a totally different section. Section 9 student organization committee rules and governance under item 3d member responsibilities. I was going to suggest changing it to "supporting the needs of student organizations because I think that's more reasonable considering we are an unpaid student government.

  - David: Section 3 the SOLO traiting. We're requiring 2 org leaders to go to these trainings but what's the difference with just having one person?

  - Joel: If it was required that it wasn't graduating seniors that would've meant that Ryan and I couldn't have been the people attending SOLO

for MCSG this year which I think doesn't make sense considering it's in the fall.
